Terms & Conditions

Reservation Deposit

Space may be secured upon receipt of deposit (30% of total cost). Deposits must be received within 7 days of booking. A reservation can be changed only if provided space is available. An entire reservation that is changed is considered a cancellation and will be subject to cancellation fees.

Payments

Balance payments should be received 30 days prior to departure. If the reservation is made less than 30 days before departure, a full payment must be made at the time of booking.

Cancellation and Refunds

Cancellations must be made in writing and signed by the tour participant in the event that a tour participant cancels his or her reservation, the following fees will apply. Cancellation fees are agreed to be liquidated damages and are not considered a penalty. Cancellation received in writing by MARMARA BABIL TRAVEL more than 45 days prior to departure are subject to an administrative fee of 10 % of tour rate per person. If your request is received within 45 days, the following fees will apply.
